

HALL OF FAME COMMITTEE

PURPOSE: To perpetuate the names of male and female members who have displayed outstanding ability in the game of American Ten Pins, either through superb performance or meritorious service.

COMPOSITION:

1. The committee chair is appointed by the President.
2. Committee members consist of a minimum of 5 Hall of Fame members and 2 members of the Board of Directors selected by the Chairman.

MEETINGS: This committee shall meet at the call of the President or Chairman.

ELIGIBILITY:

To qualify as a nominee, an individual must have been a member of the Greater Wichita Falls USBC Association for a minimum of 20 (**Adult**) years. A nominee does not have to be an active bowler at the time of nomination.

SELECTION:

The Committee and active Hall of Fame members will vote for no more than: 3 males and 3 females.

PROCEDURES:

1. Hall of Fame Nominating Forms will be mailed out or distributed by the association manager to the bowling centers, league presidents, and league secretaries by April 1. Deadline for submission of nominees must be postmarked no later than June 30, 2018. All submissions will be mailed to the GWFUSBC.
2. Candidate forms may be carried over for a period of two years (including year submitted), after that must be resubmitted to be considered for selection.
3. The Association Manager will make copies and mail all qualified forms on file to the committee members by June 15. A date for a meeting for the purpose of selection of the inductees will be set by the chair.
4. Inductees will be invited to the Annual Awards Banquet which will be at a date and time set by the Board of Directors. Inductees will receive a plaque indicating the date of induction. Each inductee will receive 2 free tickets to the banquet.
5. The committee is responsible for sending Hall of Fame members an invitation/RSVP to the Annual Awards Banquet. Invitations should be mailed out as soon as possible but no later than one month prior to the event. All Hall of Fame members will receive 1 free ticket to the banquet.
6. The chair is responsible for acquiring the USBC Hall of Fame certificate to be presented to the inductees the night of their induction. The certificates may be found at the following link:

7. Any changes in committee procedures will be given in writing to the chair of the Legislative Committee and the Association Manager.

SELECTION PROCEDURE:

1. The Hall of Fame Committee will review the completed applications, a vote will be taken, and a candidate must have a majority vote to be placed on the ballot.
2. Quorum for voting will be 10 members. This will include the committee and Hall of Fame members present.
3. Committee members and the active Hall of Fame members will review the eligible resumes. A vote will be taken by ballot and a candidate must have at least 70% of the votes to be inducted.
4. The Hall of Fame chair will compile the vote total and determine the inductees. In case of a tie, another ballot will be taken until the tie is broken.

MEMBERSHIP FEES: All members of the Greater Wichita Falls USBC Hall of Fame shall be exempt from paying any local portion of the association membership fees. The member must pay the national portion of the fee set by the USBC national bylaws.
